The Mind of Mr. J.G. Reeder

I. — THE POETICAL POLICEMAN

THE day Mr. Reeder arrived at the Public Prosecutor's office was indeed a day of fate for Mr. Lambton Green, Branch Manager of the London Scottish and Midland Bank.

That branch of the bank which Mr. Green controlled was situate at the corner of Pell Street and Firling Avenue on the 'country side' of Ealing.
